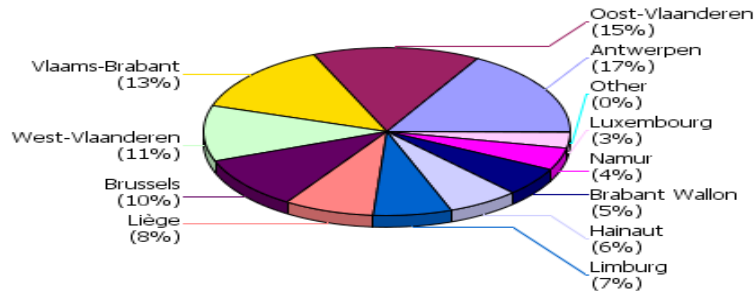

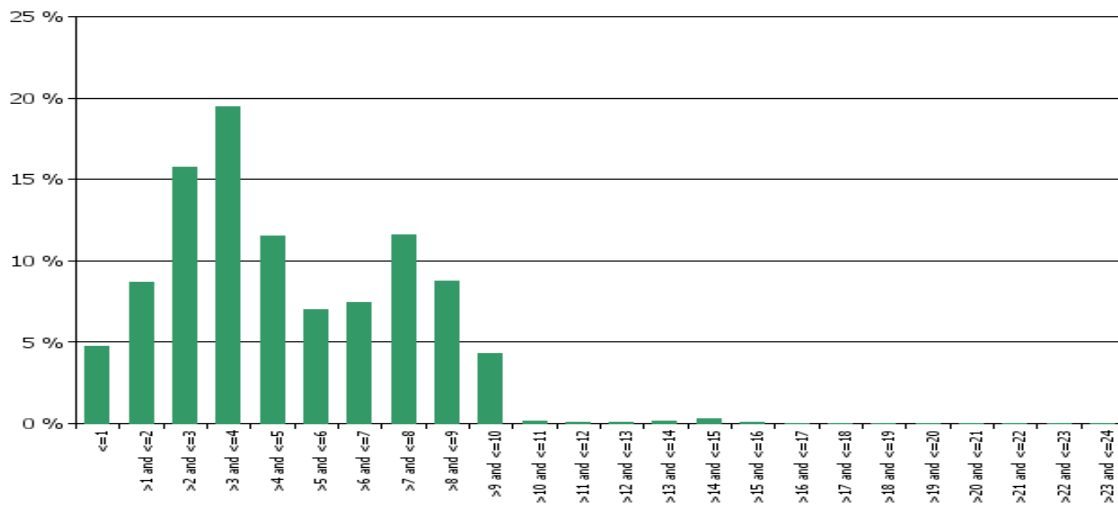

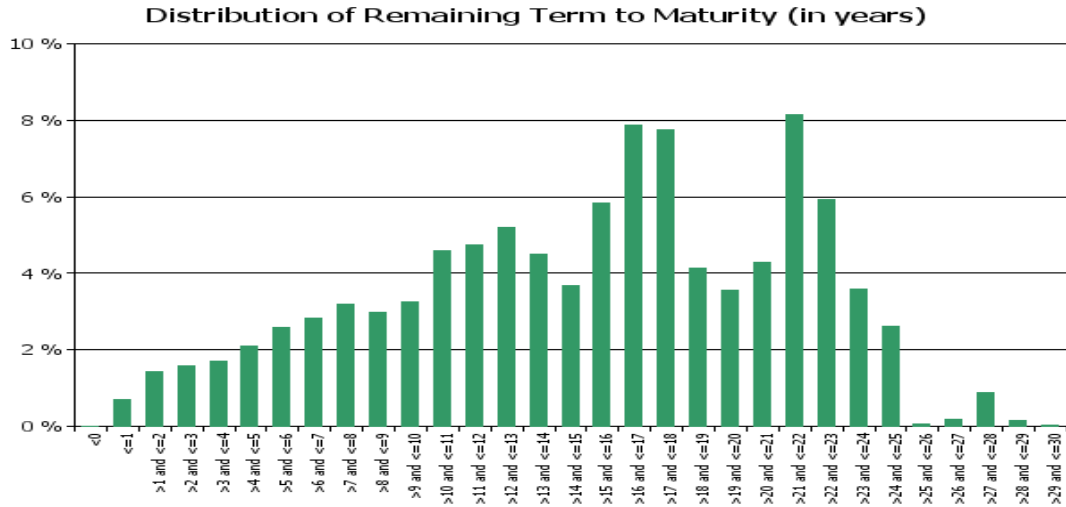

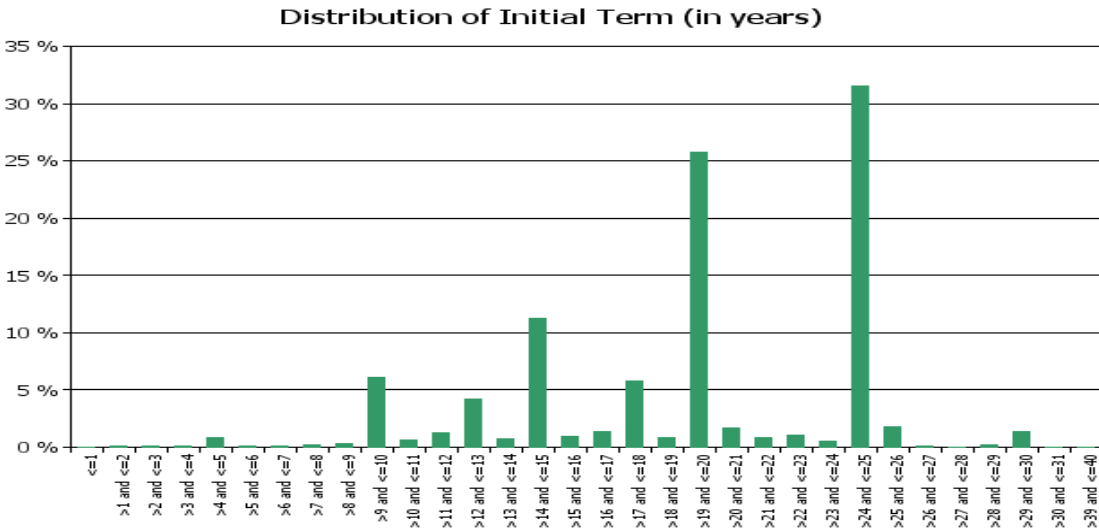
Distribution per Seasoning



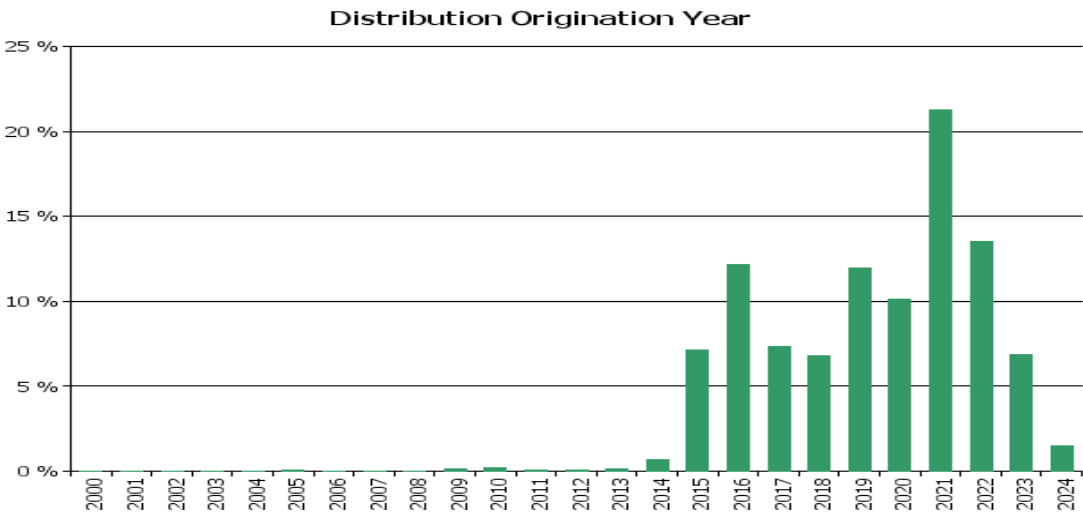

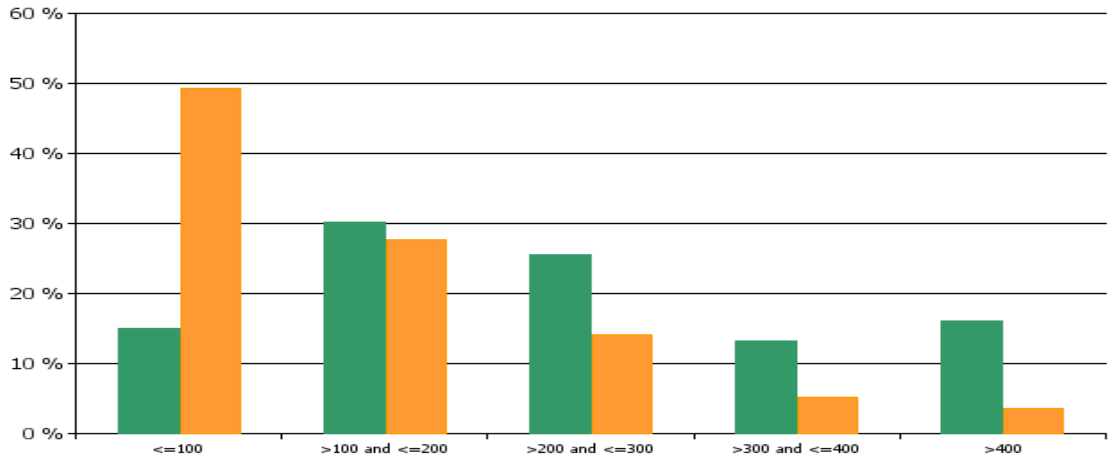

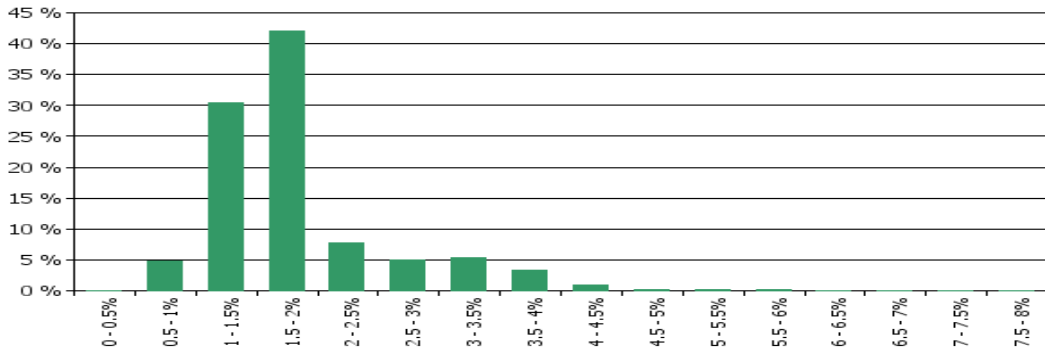

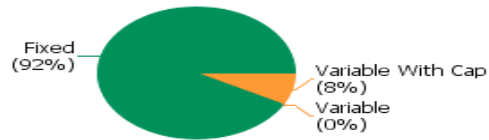

Distribution per Interest Rate

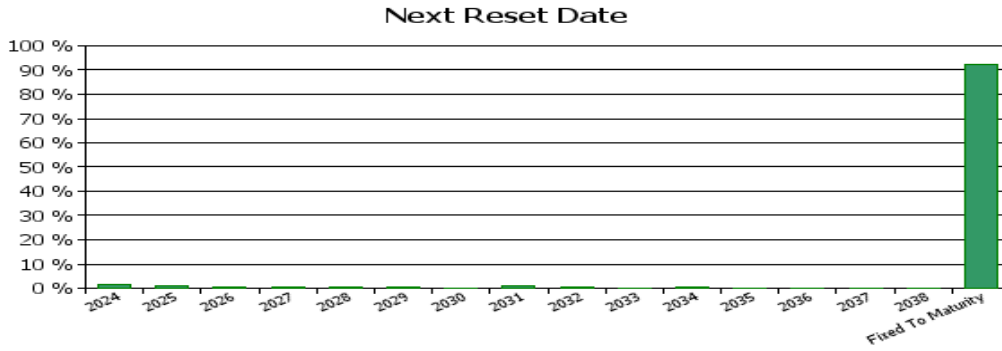

Distribution per Interest Type

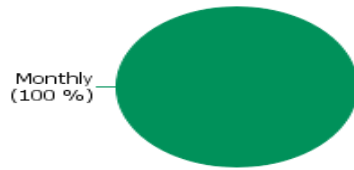

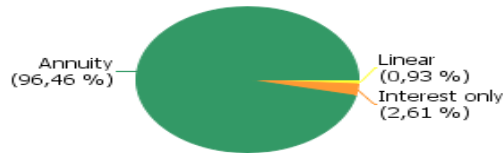
10. Interest Payment Frequency

Distribution per Interest Payment Frequency



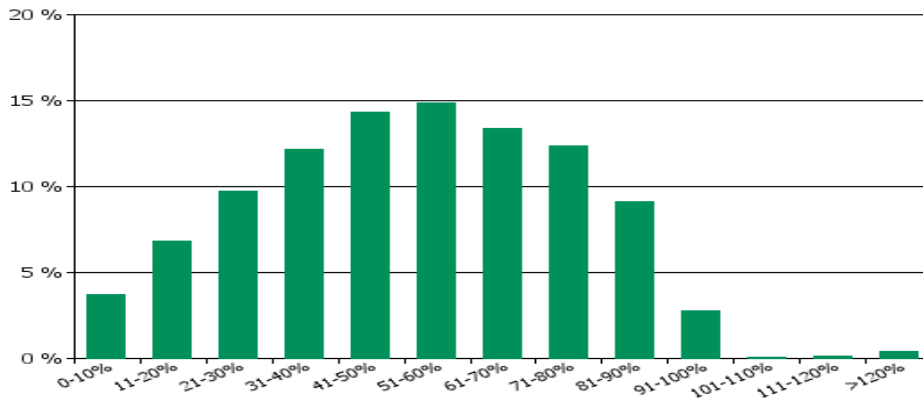

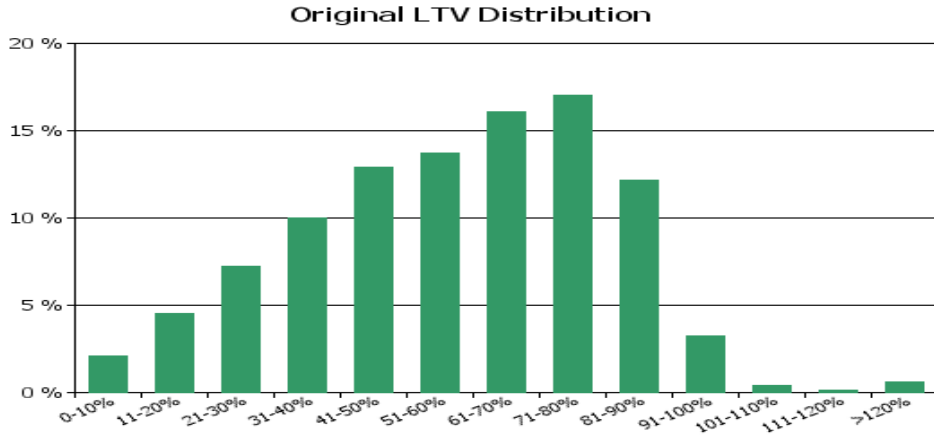

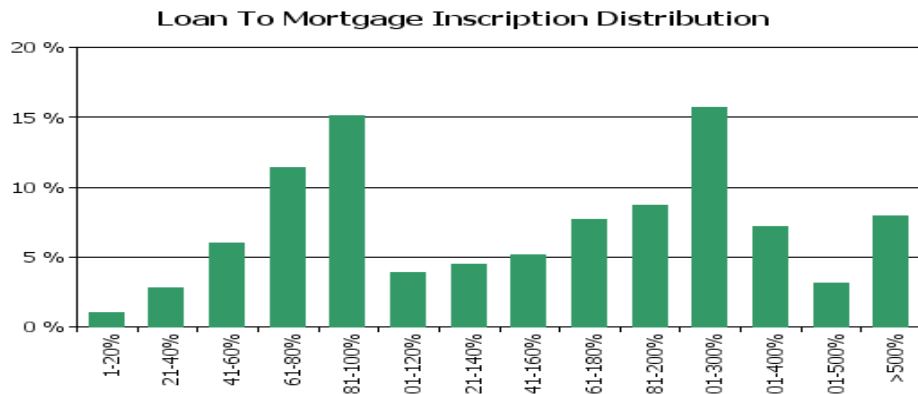
Current LTV Distribution



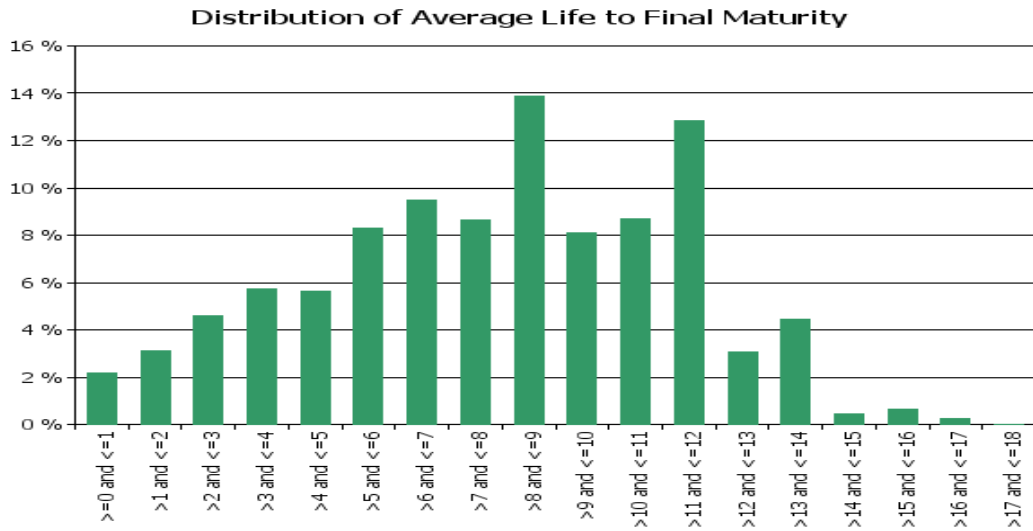

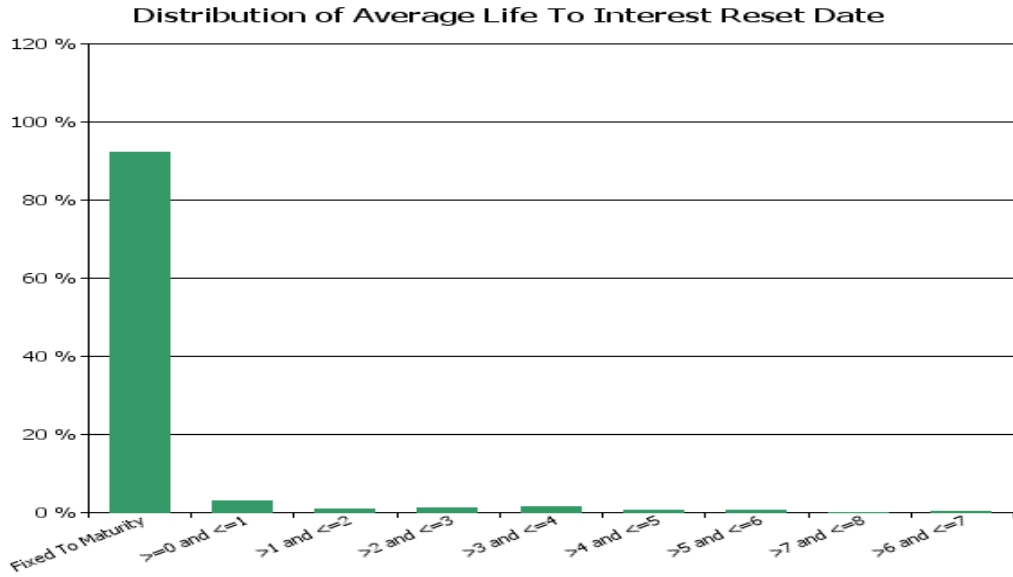
14. Loan to Mortgage Inscription Ratio (LTM)

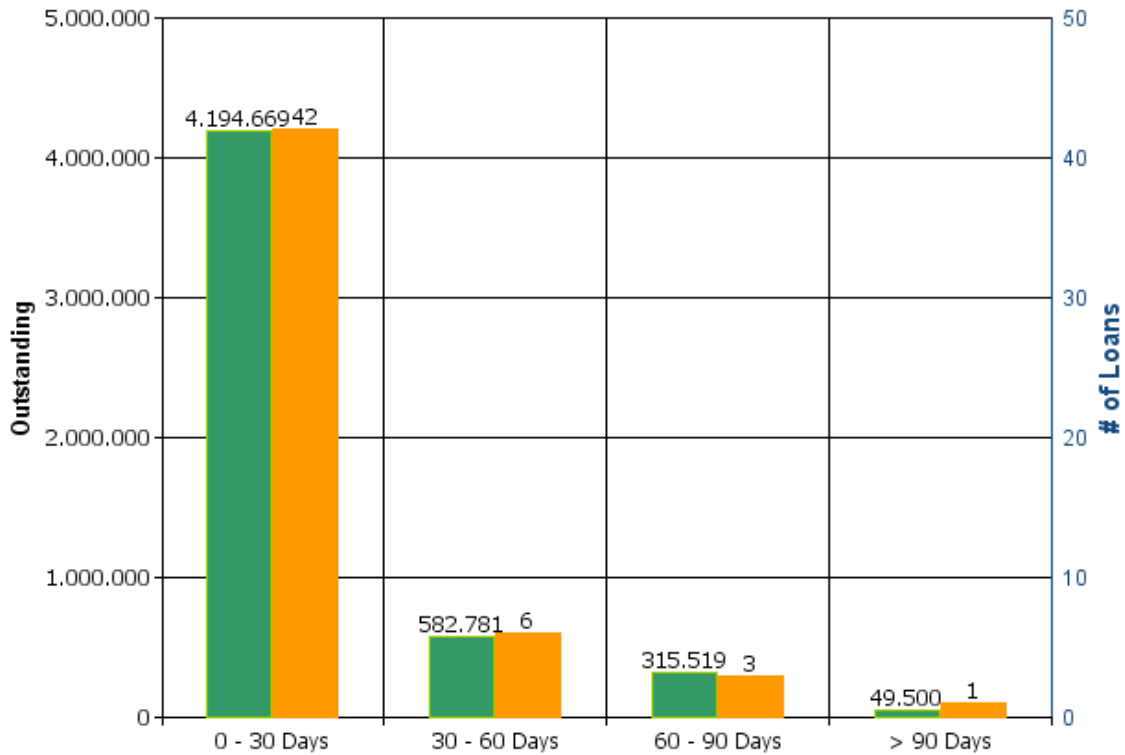

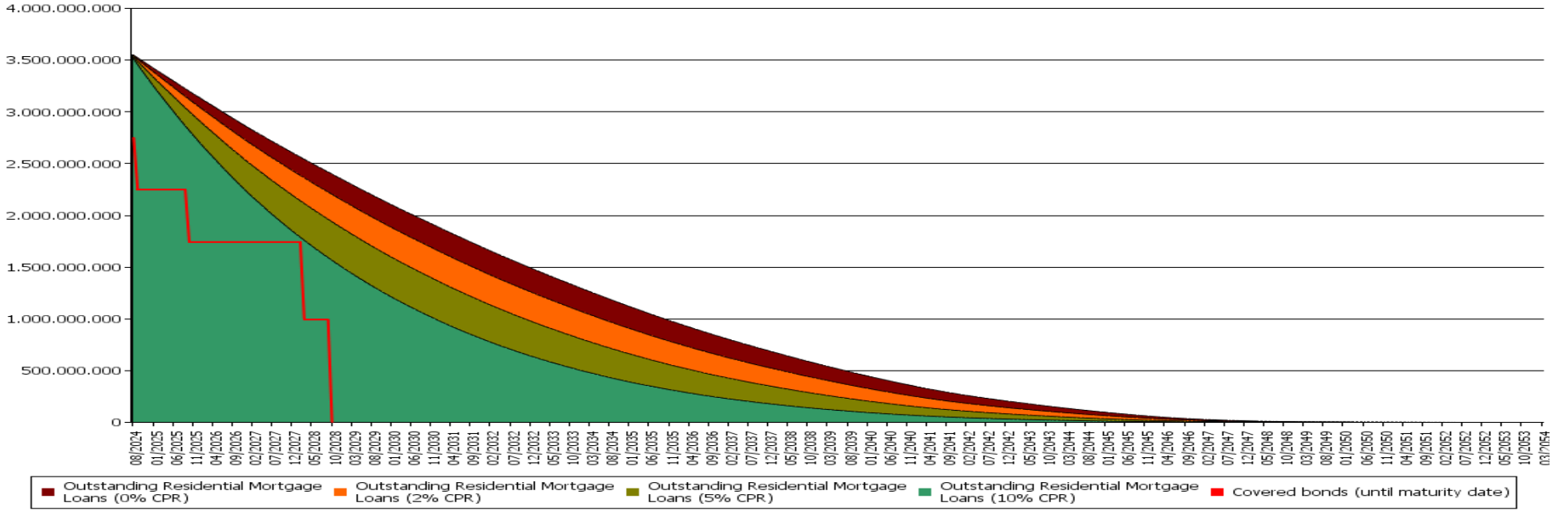
